6) Committee Reports

a) Technical Committee – Kevin W3KKC

I deal with most of the technical issues presented to this organization and in most cases, I/we even settle most inquiries and disputes before they even become official business. I am just a bit behind on coordination application review processing. East Ohio has undergone a Frequency Coordinator change, and they have shared their database with the WPRC, Inc. for Frank to use for his purposes. Several people have applied for some of the 125 open 440 pairs that were opened up by Kevin's proposed and accepted 440 band plan change about a year ago.

We received an email from a person who wanted tower space for a bit of equipment for his locating service business, in return for access to the data. After discussion, we decided that the return email should be 'no thank you' from the WPRC, Inc.

Discussion ensues; Frank indicated that we do update the ARRL database with the basic Coordination information. Steve Ford is our ARRL contact.
